### **KEY MESSAGES**

The following key messages apply to all primary health stakeholders and can be modified to complement the medium and target audience to which they are delivered.

- Statewide referral criteria provide referring clinicians clear and consistent guidance about which patients will be seen in specialist clinics within public hospitals across Victoria, and what investigations are necessary to support accurate prioritisation.
- Clinical Review Panels have recently reviewed and updated criteria that were developed and published between 2018-2020. From 1 November 2022 these updates will be ready for hospitals to implement. Several referral criteria now include reference to ongoing symptoms post-COVID-19. - From 1 November 2022 statewide referral criteria for common conditions will be available on all Victorian HealthPathways, or equivalent care pathways websites.
  - Referrals that do not meet the criteria, because they are either not suitable or are missing essential investigations or information, will be declined and returned to the referrer. The referring clinician must resubmit again in full.
  - Patients will not be provided with an appointment or placed on a waiting list unless a complete referral compliant with the statewide referral criteria is received.
- Statewide referral criteria only apply to adult specialist clinics.

#### What do referrers need to do?

GPs and other referring clinicians are encouraged to check the updated statewide referral criteria through all Victorian HealthPathways websites, or equivalent care pathways. Find your <u>HealthPathway or care</u> <u>pathways</u>.

#### What happens when a referral is incomplete or declined?

- Referrals that do not meet the statewide criteria are expected to be declined by all Victorian public hospitals. When this happens, referring clinicians should receive correspondence from the health service explaining why the referral has not been accepted.
- If a referral is declined due to being incomplete -- that is, there is missing essential information -- the referring clinician must resubmit in full. Patients will not receive an appointment or be placed on a waitlist until a complete specialist clinic referral has been received.


