# Dermatology – Children and Adults

#### Are your HealthPathways ready?

Please check that your region's HealthPathways or equivalent pathways are ready before publishing. If they are not, then social message 1 is purely about the release on 1 November 2025.

#### **Background information**

From 1 November 2025, referrals for dermatology conditions for children and adults will be assessed against new statewide referral criteria in all Victorian public hospitals.

The aim of statewide referral criteria is to streamline access to specialist clinics in public hospitals in Victoria, by reducing inappropriate referrals and overall wait times for patients. Statewide referral criteria assist referring clinicians to know when a referral to a public specialist clinic is appropriate and the information that should be included in the referral.

The Victorian Department of Health has developed and published new statewide referral criteria for eleven adult and twelve children's dermatology conditions.

#### **Adult dermatology conditions**

- Alopecia
- Assessment of acne management
- Assessment of dermatitis (eczema) management
- Assessment of psoriasis management
- Assessment of vitiligo
- Blistering eruptions, rash of unknown cause and adverse drug reactions
- Chronic skin ulcers
- Hidradenitis suppurativa
- Melanoma dermatology
- Skin and nail infections and infestations
- Skin lesions and other skin cancers dermatology

#### **Child dermatology conditions**

- Alopecia in children
- Assessment of acne management in children
- Assessment of dermatitis (eczema) management in children
- Assessment of psoriasis management in children
- Assessment of vitiligo in children
- Birthmarks
- Blistering eruptions, rash of unknown cause and adverse drug reactions in children
- Chronic skin ulcers in children
- Hidradenitis suppurativa in children
- Skin and nail infections and infestations in children
- Melanoma in children
- Skin lesions and other skin cancers in children

GPs and other primary care providers are encouraged to check <u>HealthPathways or their local pathways equivalent</u> when making referrals – this will be the quickest way to understand their local public hospital's requirements. It is also a helpful way to troubleshoot management of these conditions when a referral to specialist clinics is not indicated.

#### The benefit of HealthPathways

HealthPathways offers specific clinical advice, including alternative conservative management options and referral pathways, such as suitable allied health referral options.

Referrals that do not meet the criteria will be declined and returned to the referrer. Referrers should receive a letter from the health service clearly stating why the referral has been declined.

Referrers can seek guidance from HealthPathways to:

- Review referral criteria
- Support the safe management of patients in primary care when referral to a public specialist clinic has not been accepted or is not yet indicated.

PHNs have been funded to support the adoption of statewide referral criteria into primary health through their inclusion within HealthPathways, or equivalent online pathways. Statewide referral criteria are available across all Victorian HealthPathways websites (or equivalent online care platform for South Eastern Melbourne PHN and Gippsland PHN), alongside related clinical and referral pathways. #### Key messages

#### What is the main information for GPs?

- New statewide referral criteria for a range of children and adult dermatology conditions referrals to dermatology services come into effect from 1 November 2025.
- These criteria provide clear and concise guidance on when a referral for specialist opinion and management is indicated for a limited number of commonly presenting conditions.
- To ensure patients are able to be placed on a specialist clinic waitlist, referrals should include all information outlined in the new criteria.
- Statewide referral criteria apply to public hospitals and health services only. They do not apply to private hospitals.
- GPs and other primary care providers should check their local <u>HealthPathways or online pathways website</u> when considering a referral. If the referral is not accepted, GPs can find up-to-date clinical advice on how to effectively manage these conditions within the community.
- GPs can visit <u>health.vic.gov.au/statewide-referral-criteria</u> to view the criteria.
- Additional statewide criteria will be released for new specialty areas throughout 2026.

#### Title: Statewide Referral Criteria - new release for Dermatology conditions.

New statewide referral criteria for a range of children and adult dermatology conditions come into effect from 1 November 2025 in all Victorian public hospitals.

Patients can be placed on a specialist clinic wait list when a referring GP provides information that shows the referral meets the new children's and adult dermatology criteria.

The criteria identify the information that should be included in a referral to assess the referral and direct the patient to the best service available.




